<sup>1</sup> East Timor voted for independence from Indonesia in an August 30, 1999 referendum and was under the authority of the United Nations Transitional Administration in East Timor (UNTAET) until May 20, 2002. On May 20, 2002, East Timor became an independent nation; on that date, the United States Government established diplomatic relations with East Timor. As a result, a separate immigrant visa chargeability was established for East Timor.

<sup>2</sup> Includes visas issued under the Vietnam Amerasian category. During FY-2002, 374 such visas were issued; the foreign state breakdown is: Philippines 11, Vietnam 363.
